

TAPESTRY OF NEW YORK
COPPA PARENTAL CONSENT FORM

The Children’s Online Privacy Protection Act (“COPPA”) is a federal law that requires parents or legal guardians of children under 13 years of age to consent to the collection, use and disclosure of personal information from their children.

THIRTEEN Productions LLC (“THIRTEEN”) is a New York-based public media organization which manages the Tapestry of New York website www.tapestryofny.org. Tapestry of New York collects and publishes student-created content to a public audience for educational purposes.

Because Tapestry of New York displays certain personal information in connection with a child’s artwork – including the child’s first name and last initial (unless anonymity is requested), school/institution, school district, city/town, grade range and homeschooling status – parental consent is required for submissions from children under 13 years old. This COPPA consent is incorporated into the Tapestry of New York Privacy Policy, which is available at <https://tapestryofny.org/privacy-policy/> and explains how your child’s personal information is collected, used and disclosed in connection with Tapestry of New York.

Parents or legal guardians should print this form, complete it, sign it, and return it to your child’s teacher.

Option 1: You consent to the collection, use and disclosure of their personal information as described in the Tapestry of New York Privacy Policy. You understand that by selecting this option, your child's artwork and artist statement will be displayed on the Tapestry of New York website along with your child's first name, last initial, school/institution, school district, city/town, grade range and homeschooling status.

or

Option 2: You would like your child's work to be displayed **anonymously**. You understand that by selecting this option, your child's artwork and artist statement will be displayed on the Tapestry of New York website without listing your child's name. Your child's school/institution, school district, city/town, grade range (but not their specific grade) and homeschooling status will still be displayed. Your child's personal information will still be collected and used by Tapestry of New York pursuant to its Privacy Policy.

Option 3: You do not want your child to participate in the Tapestry of New York project. They will not be permitted to submit any artwork or other content or information for display on the Tapestry of New York website.
